Meeting called to order at 6:00 PM. Pledge of Allegiance was recited, followed by a moment of silence.

Motion 25-0127-1 Resolved, to adopt a Resolution determining to proceed with the submission to the electors the question of levying an additional tax in excess of the ten mil limitation, for the purpose of Fire/EMS Services, that the county auditor estimates will collect \$490,000 annually, at an annual tax rate of 3.5 mill(s) for each \$1 of taxable value, and which amounts \$123 for each \$100,000 of the county auditor's appraised value, for a period of 5 years, commencing in 2025, first due in calendar year 2026, if approved by a majority of the electors voting thereon. Said levy shall be submitted to the electors in the general election to be held on May 6th, 2025.

Motion 25-0127-2, Resolved, to support the Ohio Commission for the United States Semiquincentennial.
